## Update to the Standard Professional Fee Schedule for Commercial

### Laboratory codes to be adjusted

**Effective Jan. 1, 2026**, Highmark will make an update to the standard professional fee and pricing methodology<sup>1</sup>, which applies to the Highmark service areas in Delaware, Pennsylvania, and West Virginia, for its Commercial line of business.

The codes for Independent Laboratory and Physician Office Laboratory services will receive an upward adjustment on Jan. 1, 2026, and are applicable to the following fee schedules:

- Highmark Delaware PPO
- Highmark West Virginia PPO
- Keystone Health Plan West (KHPW) Network (*Western and Northeastern Pennsylvania regions*)
- PremierBlue Shield Network (*Pennsylvania*)

Once you arrive at the PRC, select **Claims & Authorizations > Reimbursement Programs > Fee Schedule Information**.
