Agitation includes: Aberrant behaviors, Verbal behaviors, or Physical behaviors.

Behavioral disturbance includes: Sleep Disturbance, Social Disinhibition, or Sexual Disinhibition.

Psychotic disturbance includes: Hallucinations, Paranoia, Suspiciousness, or Delusional state

Mood Disturbance includes: Depression, Apathy, or Anhedonia

Diagnoses in **RED** require further specificity to assign an appropriate ICD-10 code.
