Overview

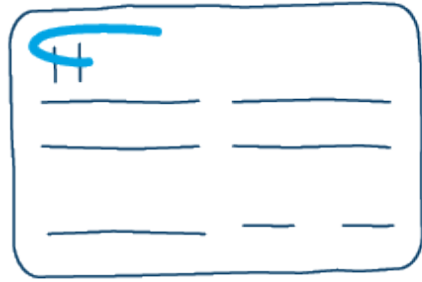
- With Well360 Virtual Dermatology Clinic, patients can share skin, hair and nail concerns with one of more than 160 certified dermatologists
- Patients can get treatment and prescriptions for chronic conditions and new diagnoses, or schedule follow-ups with a dermatologist (up to 30 days from initial appointment)
- Patients may be given a referral to see an in-network dermatologist in-person

What This Means For You

- The virtual clinic allows patients to be seen by/consult with a dermatologist sooner than waiting for in-person care or utilizing urgent or ED services for non-emergency concerns
- Ideal for patients living in rural areas, with transportation issues, or who need out of town/after-hours care
- Can reduce overall cost of care by not delaying treatment
- Patients' visit summaries can be shared with their PCP
- Patients can access Well360 Virtual Health through their Highmark member portal

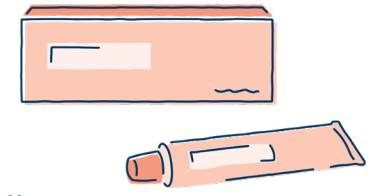
