
A virtual health solution for on-demand access to acute and chronic dermatology needs

- With Well360 Virtual Dermatology Clinic, patients can share skin, hair and nail concerns with one of more than 160 certified dermatologists
- Patients can get treatment and prescriptions for chronic conditions and new diagnoses, or schedule follow-ups with a dermatologist (up to 30 days from initial appointment)
- Patients may be given a referral to see an innetwork dermatologist in-person

What This Means For You


