Program Overview

Screening, Brief Intervention, and Referral to Treatment (SBIRT) is designed to prevent members from developing a substance use disorder, for early detection of a suspected substance use disorder, or to refer members for treatment. These services are not intended to treat members already diagnosed with a substance use disorder or those members already receiving substance use disorder treatment services. Highmark Wholecare plans compensate providers for completing SBIRT for Substance Abuse screenings/assessment in physical healthcare settings. Highmark Wholecare plans only reimburse providers for medically necessary services furnished to eligible members. The purpose of this guide is to provide education and billing guidance to providers to obtain reimbursement for SBIRT services. This guide will be updated periodically to reflect changes based upon industry standards and practice. Highmark Wholecare plans reserve the right to conduct post-payment medical record audits for validation purposes and in accordance with state and federal accreditation, your provider agreement and regulatory requirements.

Screening/Assessment

Pre-Screen (aka Brief Screen/Assessment): A pre-screen/assessment is defined by the Substance Abuse and Mental Health Services Administration (SAMHSA) as “a rapid, proactive procedure to identify individuals who may have a condition or be at risk for a condition before obvious manifestations occur.” It involves short questions relating to alcohol and drug use, and must be administered prior to beginning a full screening/assessment. **Pre-screens/assessments are considered part of routine medical management and are not a separately reimbursable service.** When the pre-screening/assessment results do not indicate any need for a full screen/assessment positive re-enforcement and education regarding prevention should still be provided and discussed.

Full Screening/Assessment: Full screens/assessments are administered after a patient has answered positively to the pre-screen/assessments questions. Full screenings/assessments entail asking patients a validated series of questions to assess the level of a patient’s substance use. **Full screens/assessments are only covered for members with positive brief screens/assessments and for members with signs, symptoms, and medical conditions that suggest risky or problem alcohol or drug use.** Full screenings/assessments should be used as a primary method for educating members about the health effects of using alcohol and other drugs. Highmark Wholecare covers screening/assessment services in a wide variety of settings to increase the chance of identifying individuals at risk for future substance abuse. Providers are required to use an evidence-based screening/ assessment tool to identify patients at risk for problems related to substance use. **There are several evidence-based screening/assessment tools including:**

- The Alcohol Use Disorders Inventory Test (AUDIT)
- The Drug Abuse Screening Test (DAST)
- The Alcohol, Smoking, and Substance Involvement Screening Test (ASSIST)
- The Car, Relax, Alone, Forget, Friends, Trouble Screening Test (CRAFT) for adolescents
- The Problem Oriented Screening Instrument for Teenagers (POSIT)

Brief Intervention

Brief interventions are interactions with patients that are intended to induce a change in a health-related behavior. When a Substance Use Disorder is diagnosed and appropriately added to the billing claim, up to three (3) follow-up contacts should be provided within the next 34 days (1) within 14 days and (2) additional within the remaining 34 days to assess and promote progress and to evaluate the need for additional services. Brief interventions are typically used as a management strategy for patients with risky or problematic alcohol or other drug use who are not dependent on the substance. Brief substance use intervention services are covered for members who, through the use of an evidence-based screening/assessment tool, are identified as at-risk for a substance use disorder(s). Brief intervention may be single or multiple sessions to increase insight and awareness regarding substance use and motivation for changes in behavior. Alternatively, a brief intervention may also be used to increase motivation and acceptance of a referral for substance use treatment. Intervention services may occur on the same date of service as the screening/assessment or on a later date. Brief intervention is not covered prior to screening/assessment.

Referral to Treatment

Patients who appear to be dependent on alcohol or other drugs should be referred to alcohol and drug treatment programs. Patients who screen positive for a Substance Use Disorder should initiate treatment within 14 days of the substance use disorder identification/diagnosis and engage in at least two (2) additional treatment services within 34 days following the identification/diagnosis of the substance use disorder.

Member Eligibility

The SBIRT benefit is available to members ages 12 and older who are enrolled in Highmark Wholecare plans.

Eligible Providers

The following licensed provider types are eligible for reimbursement for the Highmark Wholecare product line in which they are credentialed and have a current contract with Highmark Wholecare for clinical services.

- Physician
- Psychiatrist (Medicare Assured only)
- Physician Assistant (PA)
- Nurse Practitioner (NP)
- Clinical Nurse Specialist (CNP)
- Clinical Psychologist (CP) - (Medicare Assured only)
- Clinical Social Worker (LCSW) - (Medicare Assured only)
- Clinical Nurse - Midwife

**Behavioral health providers are encouraged to work with their county and/or behavioral health MCO to determine coverage for SBIRT for Highmark Wholecare's Medicaid members when the behavioral provider seeks to bill directly for services.*

Billing Information and Documentation Guidelines for SBIRT

The procedure codes used to report SBIRT services for reimbursement are consistent among all provider types. Highmark Wholecare will reimburse for the following codes:

Line of Business	Procedure Code	Description
Medicare/ Medicaid	G0396	Alcohol and/or substance (other than tobacco) abuse structured assessment (e.g., AUDIT, DAST), and brief intervention 15 to 30 minutes
Medicare/ Medicaid	G0397	Alcohol and/or substance (other than tobacco) abuse structured assessment (e.g., AUDIT, DAST), and brief intervention, greater than 30 minutes
Medicare	G0442	Annual Alcohol Screening 15 minutes
Medicare	G0443	Prevention: Up to four 15–minutes, brief face to face behavioral counseling interventions per year for individuals, including pregnant women who screen positive from alcohol misuse. No coinsurance or deductible for patient
Medicare/ Medicaid	H0049	Brief screening less than 5 minutes: Up to two pre–screens for alcohol and/or substance (other than tobacco) per 12–month period

Medicare

Documenting Medicare SBIRT Services: The patient’s medical record must support all Medicare claims. The medical record for covered SBIRT Services must:

- Be complete and legible
- Record start and stop times or total face-to-face time with the patient (because some SBIRT HCPCS codes are time-based)
- Document the patient’s progress, response to changes in treatment, and diagnosis
- Document the rationale for ordering diagnostic and other ancillary services or ensure it is easily inferred for each patient encounter, document:
 - Assessment, clinical impression, and diagnosis
 - Date and legible provider identity
 - Physical examination findings and prior diagnostic test results
 - Plan of care
 - Reason for encounter and relevant history
 - Identify appropriate health risk factors
 - Make past and present diagnoses accessible for the treating and consulting physicians
 - Sign all services furnished or ordered

Documentation Guidelines for SBIRT *Cont.*

NOTE: Incomplete records place you at risk of a Medicare partial or full payment denial. Physicians, PAs, CNMs, CNSs, and NPs may review and verify (sign and date), instead of re-documenting notes already made in a patient's medical record. These notes may have already been made by physicians; residents; nurses; medical, physician assistants; and advanced practice registered nurse students; or other members of the medical team, including as applicable, notes documenting the physician's, PA's, CNM's, CNS's, and NP's presence and participation in the service.

Medicaid

You must comply with the State's Medicaid SBIRT documentation policy. You can often find the State's documentation policy in its Medicaid Provider Manual. For more documentation information, providers should refer to their State Medicaid agency.

Additional Information

1. Screening Brief Intervention Treatment (SBIRT) is not designed to address smoking and tobacco cessation services unless it is a co-occurring diagnosis with another substance such as drugs or alcohol. Tobacco-only services are not a SBIRT billable benefit.
2. Screening Brief Intervention Treatment (SBIRT) may be provided face-to-face with the member, through telehealth/telemedicine, or telephonically.
3. A prior authorization request is not required.
4. SBIRT screenings/assessments are reimbursable as many times as needed for each patient

Training Requirements

In order to directly deliver screening, assessment and intervention services, providers are required to participate in a training that provides information about the implementation of evidence-based protocols for screening, brief interventions, and referrals to treatment (SBIRT). Face-to-face trainings and consultations are available through various entities. All providers are required to retain documentation confirming that staff providing SBIRT meet the training, education, and supervision requirements. Providers billing for SBIRT screening and assessment are required to maintain documentation of completion of an evidence based SBIRT training program. Providers may be asked to present evidence of this training if an audit occurs. If appropriate documentation cannot be produced, we retain the right to void the claim payments.

Highmark Wholecare offers the following resources for treatment:

1. Opioid Use Disorder Centers of Excellence (OUD-COEs)

These Centers of Excellence, coordinate care for people with Medicaid. Treatment is team-based and “whole person” focused — with the explicit goal of integrating behavioral health and primary care.

3. Perinatal Addiction Treatment Health Homes (PATHway)

Perinatal Addiction Treatment Health Homes (PATHway) are programs that encourage a collaborative method of treatment for support for pregnant women with substance use disorder. This program is designed to help mothers receive the medical, behavioral, social, and educational services they need to deliver healthier babies. Highmark Wholecare members who are pregnant and who are enrolled in the PATHway program will receive prenatal care, medication assisted treatment (MAT), counseling, and wrap around services, such as transportation, peer support, and child care at a health home site. Highmark Wholecare’s pregnant members also receive comprehensive case management, care coordination/navigation, peer and family support, transitional follow-up care, and partnerships with community and social service agencies to make it easier for mothers to complete their treatment plan and ensure the best possible outcomes for their babies.
