RSV Vaccines Approved for Infants, Pregnant Women, and Older Adults

The Centers for Disease Control and Prevention (CDC) has approved respiratory syncytial virus (RSV) vaccines for infants, pregnant women, and adults 60 years of age and older. These vaccines are being retroactively added to the Highmark Preventive Schedules.

Infants

The CDC is recommending a new immunization to help protect all infants under 8 months and some older babies (up to 2 years old) at increased risk of severe illness caused by RSV. The following codes apply:

Pregnant Women

The CDC approved an RSV vaccine for pregnant women to help protect newborns during their first six months. RSV can be especially harmful for infants, resulting in serious illness. Abrysvo is approved for use later in a pregnancy (weeks 32 through 36). Use the code below:

Older Adults

The CDC recommends adults 60 years and older may receive a single dose of an RSV vaccine, based on discussions between the patient and health care provider. Providers should use the following codes:

Retroactive Dates

As noted above, the RSV vaccines have been retroactively added to the Preventive Health Schedule for infants on **August 3**, **2023**, pregnant women on **September 22**, **2023**, and older adults on **July 21**, **2023**.

Member Cost Share

For members who have plans with the standard preventive schedule, it is highly likely that there will be no member cost share. However, it is possible that some members may see **out-of-pocket costs** when receiving the new vaccine if their employer does not offer the preventive benefit or their plan does not otherwise cover it.

Medicare Part D covers the RSV vaccine if it's recommended by the Advisory Committee on Immunization Practices (ACIP), a government agency that gives advice about who should get certain vaccines. At this time, the RSV vaccine is recommended for adults 60 and older.
