# **POSTPONED: Prior Authorization Changes** Coming March 1<sup>st</sup>, eviCore Training Webinars Available

Highmark Blue Cross Blue Shield of Western New York (BCBSWNY) is postponing the authorization changes outlined below. Educational webinars that were scheduled to begin this week will be rescheduled.

Effective **March 1, 2023**, Highmark Blue Cross Blue Shield of Western New York is making changes to our prior authorization requirements for some musculoskeletal (MSK) procedures and interventional pain management, molecular and genomic testing, and radiation oncology services for all lines of business. New and continuing authorization requirements for these types of services will be managed by eviCore. **Note:** Prior authorization requirements for the services listed above are waived until **March 1, 2023**.

Also, effective **March 1, 2023**, prior authorization requirements for advanced imaging and cardiology services for Medicare Advantage members will be managed by eviCore. Advanced imaging and cardiology services prior authorization requests for all other lines of business migrated to eviCore throughout 2022. **Note:** Prior authorization requirements for the services listed above are waived until **March 1, 2023**.

## **Requesting Prior Authorization**

For **dates of service March 1, 2023, and beyond**, you can begin submitting prior authorization requests for MSK, Laboratory Management and Radiation Oncology programs starting on **February 24, 2023**. The same dates apply for prior authorization requests for advanced imaging and cardiology services for Medicare Advantage members.

As a reminder, you should use <u>NaviNet</u><sup>®</sup> to submit authorization requests. A new drop-down option will be added to the *Authorization Submission* transaction on NaviNet for providers to request authorization for these programs.

You can also use the eviCore Web Portal to request authorizations or call eviCore directly at 1-888-564-5492.

For the MSK and Molecular and Genomic Testing programs, you can also fax authorization requests to eviCore at **1-800-540-2406**. Clinical worksheets for fax submissions can be accessed at <u>www.evicore.com</u>.
