Prosthetics and Orthotics Procedure Codes to be Adjusted in DE, PA, and WV

Highmark routinely reviews and adjusts its fee schedules and reimbursement rates in order to maintain appropriate and reasonable payments to providers, while reflecting current factors and trends in the marketplace.

As a result of this process, Highmark will increase fees for most prosthetics and orthotics procedure codes in Delaware, Pennsylvania, and West Virginia, **effective July 1, 2024**. This adjustment enables Highmark to maintain a consistent fee schedule in alignment with industry standards.
