## Lead Poisoning Prevention: A Call to Action in Pennsylvania

National Lead Poisoning Prevention Week (October 20-26, 2024) highlights the ongoing threat of lead exposure, especially for children.

Lead can be found in homes, daycare centers, schools, and even food packaging, causing serious health problems, such as developmental delays, learning difficulties, and hearing issues.

**Pennsylvania faces a critical situation:** It ranks second in the nation for both the number of children with elevated blood lead levels (EBLL) and for under-testing. In 2021, nearly 5,000 children under 6 years old had confirmed EBLL.

Highmark Healthy Kids (CHIP) requires lead blood testing for all members between 9 months and 2 years old. Testing is also required at 12 and 24 months for Medicaid-covered children.

### **Recommendations for Providers**

Practitioners are urged to:

- Talk to parents about lead poisoning and the importance of testing.
- Perform lead blood testing at every office visit, including sick visits.
- Utilize in-office testing, if available, for convenience and continuity of care.
  - Use CPT code 83655 for lead screening laboratory-chemistry test (capillary specimen or venous blood).
- Report all blood lead test results to the Pennsylvania Department of Health.

The department's Lead Surveillance Program tracks and monitors childhood lead activity through the Pennsylvania National Electronic Disease Surveillance System (PA-NEDSS), a web-based application system that receives all lead reports on Pennsylvania's children.

Through PA-NEDSS, the Division of Child and Adult Health Services can identify possible high-risk areas, locate areas of under-testing and identify other potential service gaps.
