NATIONAL IMMUNIZATION AWARENESS MONTH

August is [National Immunization Awareness Month \(NIAM\)](#). This annual observance highlights the efforts of Highmark to protect members of all ages against vaccine-preventable diseases through on-time vaccination. Immunizations are especially important while the public health pandemic continues as members' ability to attend important appointments and receive routine vaccinations has changed.

Many members had to postpone or cancel appointments and may not have had the opportunity to catch up on needed healthcare. During NIAM, encourage members to schedule appointments to ensure they are up to date on annual exams and recommended vaccines. Research shows that you are the most trusted source of vaccine information for parents and members.
